### Bill 139 (OMB Reform)

On Dec 12, 2017, the Ontario legislature passed the Building Better Communities and Conserving Watersheds Act, 2017. This Bill 139 will replace the Ontario Municipal Board (OMB) with a new Local Planning Appeal Tribunal.

The legislation includes reforms that will:

- Eliminate "de novo" (entirely new) hearings for the majority of land use planning appeals. Instead, the tribunal will function more like a true appeal body for major land use planning decisions.
- Under the new standard of review for land use planning appeals involving matters like official plans and zoning bylaws, the tribunal will only be able to overturn a matter if the tribunal determines that the municipal decision is inconsistent with, or does not conform to provincial policies and municipal plans.
- Establish clear timelines for the hearing process to help ensure timely decisions.
- Eliminate lengthy and often confrontational examinations and cross-examinations of witnesses by parties and their lawyers at the oral hearings of major land use planning appeals.
- Establish the free Local Planning Appeal Support Centre, a new provincial agency, offering guidance on the Tribunal process and general planning matters as well as providing planning and/or legal representation in some cases.
- Provincial approvals of official plans and official plan updates, including approvals of conformity exercises to provincial plans will be shielded from appeal.
- Secondary Plans (such as Midtown in Focus in the Yonge-Eglinton area) will be shielded from amendment applications for 2 years after approval.

### Bill 139 Transition

FoNTRA submitted a letter to the Ministry of Municipal Affairs and Housing on Dec 19, 2017 asking that "All appeals filed after Royal Assent on 12 December 2017 should be considered under the new rules by the Local Planning Appeals Tribunal regardless of the date of complete application." As it currently stands, an appeal can still be filed even after Royal Assent and before the Proclamation Date (which remains unknown at this time). This is an important issue as developers will be rushing to submit their appeals before the Proclamation Date to be considered under the 'old' rules.

## FoNTRA Year End Report

SAHRA is an active member of The Federation of North Toronto Residents' Associations (FoNTRA) a non-profit, volunteer organization comprised of more than 30 member organizations that includes approximately 170,000 Toronto residents within their boundaries. FoNTRA is very active at the Provincial and Municipal level on development, environmental balance, fiscal viability, infrastructure investment and social renewal issues. They have had a very busy and productive 16<sup>th</sup> year – the following major issues are summarized in the attachment 'FoNTRA Year End Report eBlast outline'.

## 3-storey Appeal to TLAB

In July, 2017, the Committee of Adjustment (CofA) approved an application for a 3-storey application at 79 Felbrigg. SAHRA appealed the decision to the Toronto Local Advisory Board (TLAB) as the By-law in effect in our Neighbourhood specifies that the maximum number of storeys permitted is two. The Appeal was heard on Dec 7, 2017 and the Decision was released on Dec 21, 2017. TLAB has accepted the evidence of the professional planners that the variance for the third storey does not meet the intent and purpose of the Official Plan and zoning by-laws and is not desirable for the appropriate development of the land and is not minor. Accordingly, the SAHRA appeal was allowed and the variances requested for the 79 Felbrigg application are not authorized.

## Winter-wise tips (compliments of Toronto Water)

The pipes in your home can freeze in cold weather. This can leave you with no water or cause pipes to burst, leading to expensive property damage. If your pipes are prone to freezing, you may wish to contact a plumber for advice. Here are some other tips to help protect your home:

- Wrap foam pipe insulation around pipes most susceptible to freezing temperatures (e.g. near outside walls, crawl spaces, attic, garage).
- Seal air leaks in your home and garage to stop cold air from getting in. Check around windows and doors, electrical wiring, dryer vents and pipes.
- Outdoor pipes are the first to freeze. Unscrew hoses, turn off the outdoor water supply and allow the taps to drain.
- Ensure you know where the main water shut-off valve is in your home and how it operates.

Other important tips:

- Clear eavestroughs and downspouts of debris.
- Seal window wells and fix cracks in basement walls that could cause leaks.
- Keep rain and snow away from the foundation walls.
- If it is safe to do so, clear roadside leaves and other debris from catch basins (the square grates on the road) to help water enter the storm sewer.
- Clear snow from around fire hydrants to keep them visible and accessible to Fire Services and Toronto Water staff.

## IT and Electronic Equipment Disposal

The Electronic Recycling Association (ERA) is a not for profit organization dedicated to reducing electronic waste through the reuse and recycling of unwanted electronic/IT equipment. They collect all kinds of equipment (computers, laptops, printers, telephones, etc) to refurbish and donate to various charities and non-profit organizations. They will:

- Pick up all of your old IT & electronic equipment you don't need any more at your site
- Remove all of your data from computers according to NAID standards (**free** hard-drive wiping services plus data removal certificate)
- Refurbish your donated items and donate them to local charities in need on your behalf
- Recycle locally all of the equipment that cannot be reused
