SAHRA Information – April 9, 2018

Toronto Aviation Noise Group (TANG) Open House

It has been six years since T.A.N.G. began their advocacy on the issue of aircraft noise in our neighbourhoods and they are still at it! There have been countless meetings with elected officials at all levels and a number of independent studies, third party reviews and consultations initiated by NAV CANADA and the GTAA. TANG has been a respected, full time participant at all these events and continues to lend its voice on your behalf for a fair, balanced approach to flight path routes and airspace implementations.

They are pleased to inform you that a number of the "technical" initiatives we proposed have been successfully studied and will soon be implemented. Some include a retrofit (installation of a vortex generator) of noisy aircraft, some changes to increase aircraft altitudes on arrival and a new route for restricted hours (12:30am to 6:29am) flights. They welcome these positive changes.

What remains unresolved is the disproportionate utilization of runways at Pearson Airport. Our communities, affected by airspace changes in 2012, still account for 40 percent of all arrivals! Recently published data from the GTAA indicate that our current, annual flights of 88,000 flights (2017) will grow to over 120,000 because of projected growth plans at Pearson.

On the evening of April 12, 2018 at 7:00 the GTAA will be hosting a Community Open House at the Leaside Gardens (William Lea Tea Room) to discuss their airport operations and noise abatement initiatives. The "come and go" format allows residents to get answers to their questions without having to sit through a long presentation they don't understand. It is crucial that a large number of residents attend this event as a demonstration of our communities support of TANG and the aviation noise issue. Numbers mean everything at this point of our advocacy. Our elected officials have been invited to attend.

Notice of Motion to be presented at the Annual General Meeting

A proposal will be submitted at the April 11, 2018 Annual General Meeting to amend the Constitution for Meetings.

The fiscal year was set as the period from Jan 1 to Dec 31 (as opposed to the original definition of May 1 to April 20th) at the AGM on June 15, 2005. At that time a motion was also approved to require that the AGM be held within sixty (60) days of the fiscal year (as opposed to the original definition of 30 days).

For various reasons (completion of the Financial Statements, the Corporate Return and receipt of the Acceptance Notice, the membership campaign, timing of the release of the Winter Newsletter, the weather conditions, March Break absences, etc.), since 2009 the Board has scheduled the Annual meeting in the month of April. The Board would therefore wishes to amend the Constitution to require that the Annual member meeting be held within 120 days of the fiscal year end (Dec 31).

The motion is to amend the second paragraph of Article VII – MEETINGS:

Current Statement:

The Annual meeting of the members shall be held at such time and place as the Board of Directors determine, but must be within thirty (60) days of the fiscal year-end. Members shall be notified at least seven days prior to the meeting.

Proposed Statement:

The Annual meeting of the members shall be held at such time and place as the Board of Directors determine, but must be within one hundred and twenty (120) days of the fiscal year-end. Members shall be notified at least seven days prior to the meeting.

250 Lawrence Ave West fundraising

Councillor Jaye Robinson's Ward 25 Crime and Safety Meeting

More than 300 residents gathered at the Lawrence Park Community Church in February to voice their concerns to the TPS officials in attendance, including Chief Mark Saunders, Superintendent Rob Johnson, of the 32 and 33 Division, and senior officials from the 53 Division.

Chief Saunders highlighted the new strategy to modernize policing in the City of Toronto. For example, TPS division boundaries are currently being reconfigured to align with neighbourhoods and streamline resources. In Ward 25, the divisions bordering Bayview Avenue will be consolidated to better serve the community.

The overarching concern expression by the neighbours during the concluding question period was the high number of break-and-enters in Ward 25. In response, TPS officials suggested several preventative tips and strategies, including:

- Make your home look "lived in" while you are away for an extended period of time by:
 - Arranging for a neighbour to park in your empty driveway
 - Using timers to maintain normal lighting patterns
 - Temporarily halting mail delivery
 - o Asking a neighbour to put a garbage bin in front of your house on collection day
- Contact your respective divisional Crime Prevention Officers for assistance in developing a customized home security strategy.

Above all, the TPS representatives emphasized the importance of community cooperation and reiterated their commitment to proactive policing in our neighbourhoods. You should report any suspicious activity you observe, as the police use reporting data to direct resources.
