250 Lawrence Avenue OMB/LPAT Hearing

A packed courtroom greeted the OMB/LPAT Adjudicator Gerald Swinkin when he arrived on Tues, May 22. Over 70 members of the community were present showing our great interest in this proposed development. Over the next five days, 8-12 people attended daily.

Three of our Participants presented their Statements on Tues and the remaining five Participants were heard on Thursday. Thanks to the Participants for their great efforts!

The developer's lawyer took Tues, Wed, Thurs and part of Friday with the testimony of their planner, Michael Goldberg and urban designer, Mr. Glover. The City's Planner and Urban Designer witnesses testified on Friday and Monday. Our Expert Witness Planner, Terry Mills, testified on Tuesday followed by closing statements by the City's lawyer, our lawyer and the developer's lawyer. The Hearing finished after 6 days on May 29th. We now await the Adjudicator's Decision. An update on May 29th with pictures is attached.

Thank you to everyone who made a donation, posted a lawn sign and/or came to the Hearing. The three resident associations (South Armour Heights, Old Orchard Grove and Lytton Park) want to thank you all most sincerely for your part in ensuring our community continues to be a great place to live!

We will publish information on the Decision as soon as it is published – could be anywhere from one to four months.
