Neighbourhood Scam

A SAHRA member wrote to us today about a scam they encountered in our Neighbourhood. It involved a supposedly empty car blocking in their legally parked car. When the owner tried to move their car, three men appeared, accusing the owner of damaging their car and demanding payment. It is recommended that you call the Police if this should happen to you.

Another reason not to use mobile devices while driving

A Distracted Driving conviction will have far reaching effects – not just on your driving record but on your pocketbook as well. The Automobile Protection Association article (https://www.apa.ca/newsitem.asp?id=1128) states "Because of the increased fine and suspension, this will now be rated by insurers as a "major" offense instead of a "minor" infraction. With this elevated designation comes serious premium impact. A "major" offense is ineligible in the regular market for new business and renewals for most insurers. Because major offenses carry a surcharge, only substandard or "grey" market carriers will consider writing drivers with these offenses. This would mean a substantial increase in your premium or a cancellation for underwriting reasons upon renewal. Even if you received the ticket prior to Jan 1, 2019, if it appears on record, an insurer can and will charge for it as a major offense."
