## Sidewalk, Curb and Road Repairs on Upper Avenue

The City delivered a Construction Notice to the stores and offices on Upper Avenue (between Lawrence and Wilson) advising of sidewalk, curb and road repairs from Jul 4 to Jul 28<sup>th</sup>. They will be repairing cuts made to the sidewalk and/or road by utility companies, private contractors and the City when installing or repairing underground infrastructure (water, sewer, natural gas, cable, etc.) . The Construction Notice is attached. The work is extensive – close to 180 locations will be repaired. All of the locations are marked on the ground with white arrows, with the arrows indicating limits of repair. There will be road and sidewalk restrictions within the construction areas. The work appears to be moving up the street swiftly. This work will certainly impact traffic and pedestrian flow on Upper Avenue so please be aware/patient of this for the next couple of weeks. The result should be safer sidewalks as well as an improved appearance for Upper Avenue.

The City of Toronto (Municipal Licensing and Standards) is reviewing by-laws related to temporary signs, payday loan establishments, property standards and building maintenance, and wants your feedback!

#### 1. Temporary Signs By-law Review

The review aims to modernize the by-law and make it easier for the public to understand the rules governing temporary signs, such as A-frame signs, garage sale signs, mobile signs, new development signs, open house signs and real estate signs. In addition, the review is considering regulations to permit temporary signs that display messages of public interest and construction-related signs on private property.
